

SPCB Privacy Notice

This privacy statement explains how we collect and use personal information about you for the following process:

Presiding Officer's Office: Briefing Notes for Presiding Officers

The categories of information processed

Normal Data: names, addresses, email addresses, phone numbers and other biographical details, as per officially supplied CV's, or information gained from public source

Special category data in the form of political views and affiliations.

Source of the information

This information is provided by the data subjects and/or their representatives/organisations i.e. Embassies, High Commissions, Parliaments, Ministries, external Media or Internal Media Office, etc..

The purpose(s) of the processing

The purpose of the processing is to provide a full briefing to the Presiding Officers about visitors and guests.

The legal basis of processing

The legal basis for processing the data is that it is necessary for a task carried out in the public interest or in the substantial interest in accordance with Art 6(1)(e) GDPR, s8(d) DPB, or Art 9(2)(g) GDPR, s10(3) of and para 6 of Schedule 1 to the DPB. The task is to facilitate the PO's engagement with official visitors and guests to the Parliament. The full briefing of the PO for effective interaction with visitors is in the substantial public interest.

Data sharing

The data is only shared internally.

Retention of data

The data is retained for a maximum of 5 years (full parliamentary session).

Your rights

The GDPR sets out the rights which individuals have in relation to personal information held about them by data controllers. These rights are listed below, although whether you will be able to exercise each of these rights in a particular case may depend on the purpose for which the data controller is processing the data and the legal basis upon which the processing takes place.

Access to your information – You have the right to request a copy of the personal information about you that we hold. For further information, see our Data Subjects' Access Requests Policy.

Correcting your information – We want to make sure that your personal information is accurate, complete and up to date and you may ask us to correct any personal information about you that you believe does not meet these standards.

Deletion of your information – You have the right to ask us to delete personal information about you where:

- You consider that we no longer require the information for the purposes for which it was obtained.
- You have validly objected to our use of your personal information – see *Objecting to how we may use your information* below.
- Our use of your personal information is contrary to law or our other legal obligations.

Objecting to how we may use your information – Where we use your personal information to perform tasks carried out in the public interest then, if you ask us to, we will stop using that personal information unless there are overriding legitimate grounds to continue.

Restricting how we may use your information – In some cases, you may ask us to restrict how we use your personal information. This right might apply, for example, where we are checking the accuracy of personal information about you that we hold or assessing the validity of any objection you have made to our use of your information. The right might also apply where this is no longer a basis for using your personal information but you don't want us to delete the data. Where this right is validly exercised, we may only use the relevant personal information with your consent, for legal claims or where there are other public interest grounds to do so.
