CONSIDERATION OF PETITIONS PE1098 and PE1223

PE1098: Calling for the Scottish Parliament to urge the Scottish Government to make provision for every school bus to be installed with three point seatbelts for every school child passenger and to ensure that, as part of a local authority's consideration of 'Best Value' in relation to the provision of school buses, proper regard is given to the safety needs of the children.

PE1223: Calling on the Scottish Parliament to urge the Scottish Government to take all appropriate action, whether through amending guidance, contracts, agreements or legislation, to require local authorities to install proper safety signage and lights on school buses, to be used only when school children are on the bus when necessary, and make overtaking a stationary school bus a criminal offence.

I refer to the discussion by the Public Petitions Committee yesterday on the above petitions. The Committee was in receipt of my letter to you of 16 December 2010 and your reply of 24 January 2011.

You will be aware of our strong desire to make progress with these petitions. That message was made clear when your predecessor Stewart Stevenson MSP appeared before us on 26 October 2010. From that very useful discussion involving Mike Penning MP we had expected, given the helpful suggestion Mike made to engage in discussion with the Scottish Government about devolving power on school bus safety, for this to have been taken forward promptly after that meeting. However, we find ourselves, three months on, with no news to report on the progress of such discussions because a meeting between you and Mike has not yet been arranged.

This is extremely frustrating not just for this Committee but also for the petitioners. Given the subject matter we expected movement on this by now, particularly given the open offer which the UK Minister made.
