24 September 2013

(1) AGM

Attendance: 4 MSPs, 32 non-MSPs

An emergency resolution was passed at the AGM suspending the membership of Scotland for Animals for one year. Further resolutions were not moved. The Convener, vice-Conveners and Secretary were re-elected. The Secretary advised that OneKind wished to relinquish the secretariat at the next AGM.

24 September 2013

(2) Meeting

Attendance: 3 MSPs, 26 non-MSPs

Jim Wilson of the Scottish Government Justice Department updated the Group on Control of Dogs legislation. Members agreed to review the survey on CCTV in slaughterhouses and to arrange a meeting of the CCTV sub-group. John Brady of OneKind introduced a discussion on pet vending in Scotland.

10 December 2013 (informal – not quorate)

Attendance: 1 MSP, 31 non-MSPs

Members discussed themes for the planned CPGAW exhibition to take place in the beginning 12 May 2014. The Group resumed the discussion on pet vending begun on 24 September. It was agreed that the Convener would issue a press release on behalf of the Group advising against acquiring a pet for Christmas.

Following discussion of legislation and/or guidance on the installation and use of CCTV, it was agreed to write to the Cabinet Secretary for further information on the availability of guidance.
