1. Welcome and Apologies.

2. Minutes of the previous meeting

4. Crofting in Land Reform

A presentation by Brendan O'Hanrahan, a director of the Assynt Foundation on the role of new crofts in Scotland.

Main points:

Glencanisp is one of the biggest community-owned estates in Scotland.

It is difficult to manage land-reform in small rural communities.

There are no crofts on the estate so it was the intention to create some – the land at Ledbeg (Ledbeg house was formerly the farm house) is the significant patch of in-bye on the estate. Received help from SCF, HC, HIE, NTS (Balmacara) in the planning of the crofts. There is interest in crofts but the priority is housing.

This area (Elphin) is demographically declining in that any houses that come up for sale go to retired in-comers. So the new crofts could provide housing and land for young families. The planners were not very keen on the plans; their view was that "the area is characterised by isolated dwellings". Well it wasn't; there used to be a community there and there is evidence of it.

If there were to be consideration, the planners wanted full project detail including services etc. This put it out of reach as that level of detail would very expensive and time-consuming. Scottish Government need to decide – if new crofts are wanted a realistic method needs to be set up. The demand is there but SG record on the creation of new crofts is poor.

The 2003 Land Reform Act started off well then activity declined as the difficulties became apparent – a buyout can take 10 years at least. So it has lost momentum and crofting is part of land reform.

This could be supported through HIE and Las.

The Land Reform Bill is not just about communities buying estates – it should also include crofts, woodland crofts, small-holdings, allotments and so on. Small parcels of land get more people using the land.

There is a lot of interest in woodland crofts but FCS need to be conducive. It is not easy for individuals or even groups to buy forestry land.

The CHGS could be used to help build more houses on croft land.

Strathbrora is now empty but it used to be populated. Good in-bye is left for the deer to graze – this is not right.

Discussion

Was planning the big problem?

It was one of the problems. There was also disagreement over the use of Ledbeg House. But planning is not good with models that are not within the standard. Councillors say they are supportive but they are not supportive enough when it gets to the planning committee. Crofts seem to no longer have a presumption to have a house. If new crofts are created there should be a presumption that they have a house on them. Rules for the creation of new crofts need to be established. Planning is a nightmare in this country – it induces so much stress.

The Community Land Fund has focussed on buying land but more should go to helping the community then develop their land. It is after the buy-out that communities really need help in developing their asset, to keep up the momentum. This is especially true of crofting communities.

MSPs would like to help with this but really just don't have the facility to do so. Can Crofting Commission help?

Crofting Commission have no remit for crofting development any more – it is with HIE. HIE provide after-care support – it is with the Community Assets Team.

Do private estates have any desire to create new crofts? Possibly – as part of Land Reform in Scotland. It may be of interest to SLE?

How many crofts were planned for in Ledbeg? There is 30ha so 4 crofts, possibly 3.

It would be useful to prepare a short paper on these issues for the Scottish Parliament. Who?

If SCF start something CC can help on the regulatory side.

The West Harris Trust put up 10 new houses 5 years ago; it would be much harder to do that now.

Planning seems to stand in the way of community development. The planners say it is down to the Local Plan, but this seems to be a 'get-out'.

It is not just community-owned land; any land will run in to the same problems.

What happened to the idea of a deer farm on Glencanisp? It was decided against for marketing reasons.

Action: SCF / CC to prepare a brief paper on the creation of new crofts.

5. Crofting Development (Standing item)

CC: The issue of the convener is not settled yet but it is being worked on; the crofting census has an 84% return, and 90% of responders say they are working their croft. Statistics are available from CC.

Discussion:

What will CC do about those who didn't respond and those who have said they don't use the croft or live on /near it?

The CC doesn't have the resources to deal with this, the aftermath of the census.

What's the point of it?

It is in the act so the CC has to do it. The intention is to understand more about what is happening on the ground. It can help in tackling absenteeism and neglect by identifying who aren't using their crofts. Ultimately the purpose is to free up crofts. It also provides information on what crofters are doing which can be collated as 'the situation of crofting' report.

SG: SRDP is now approved by the EC and the CHGS analysis should be completed and published within 2 weeks.

HIE: Are working on how to work with partners in crofting community development.

Stakeholder Forum: Are working on a draft vision for crofting; will meet again as an enlarged group in a facilitated workshop.

This could be linked with the potential crofting conference?

The last crofting conference was hosted by CnES 5 years ago. Will HC host one this year?

Action: Jean Urquhart to talk to contacts in HC.

Film: 'Crofting's new Voices' was shown and greatly appreciated. This film, produced by Robin Haig on behalf of the SCF Young Crofters gathering, was funded by the CC. The film is receiving acclaim and is **now online**.

6. CAP and Crofting (Standing item)

SG update on CAP / SRDP reforms

The ANC group met – the minutes are on SG website.

The SAF deadline is 15 June. So far 12,500 have been received with an expected 21,000 total. 15 June is also the deadline for National Reserve applications.

The RACCE has concerns regarding the implementation of CAP, especially the IT. £150M has been spent yet it doesn't seem to work. There is a letter from RACCE to SG (R Lochhead) voicing "extreme concern" on the SP website.

Paper forms are now available again, prepopulated. This will be widely advertised.

It is impossible to register common grazings as the system wants them as an individual business whereas all shareholders have their own business identification numbers registered.

The regions (2 and 3) are contradictory on common grazings. As usual the SG system simply cannot cope with common grazings.

SG will convene a stakeholder group to discuss common grazings & CAP issues.

Bad weather payments: SG will convene a working group. WI will have a particular problem with diminished crops and a further increase in wild goose numbers.
