**1. Welcome and introductions**

Michael welcomed all members to the meeting and confirmed that the Group was now formally registered.

**2. Minutes of the last meeting and matters arising**

The minutes were approved as an accurate record.

### 3. Welfare Reform or Plain Old Fashioned Cuts?

Bill Scott, Inclusion Scotland, gave a presentation on the extent of the impact of proposed and adopted welfare reforms on disabled people in Scotland (copy attached). This was followed by a discussion, during which the following issues were raised:

- Some of these measures are already in place, some have still to be introduced. The Welfare Reform Bill will be debated in the Lords again at the end of this year.
- LibDem Youth have lodged a motion at their Scottish conference opposing ESA. There could also be a motion at SNP conference.
- A significant number of decisions are being reversed on appeal. However, legal aid is no longer available, which prevents many test cases being brought. 70% of those with representatives are successful at appeal.
- There is now a huge backlog of appeals waiting to be heard and a significant overload on advice services, particularly as the number of welfare rights officers has been reduced.
- There is potentially a significant loss of income to the Scottish economy, eg £16m from ILF.
- Legislators need to apply Equality Impact Assessments. Cumulative changes to benefits may have a disproportionate impact on women.
- People with learning disabilities and mental health issues currently on the Lower Rate Care component of DLA are unlikely to qualify for PIP at all.
- Scottish Coalition on Welfare Reform has written to committees requesting consideration of the Legislative Consent Motion and also that an ad hoc committee on welfare reform be established. Other Scottish Parliament Committees can be asked to consider the Legislative Consent Motion. Discussions have taken place at the Equal Opportunities Committee.
- Over 300 passported benefits will be affected by changes to benefits.
- Disability Alliance and Disability Benefits Consortium have lodged an intention to take some cases to Judicial Review.
- Worklessness due to ill-health and disability is higher in Scotland than elsewhere and therefore welfare reform will impact on more people. Advisors from disability organisations working on the new Work Choice programme reported that their recommendations had been ignored.
- There are fewer people on Access to Work.
- Disabled people are often unfairly selected for redundancy or ill-health retirement.
- The removal of mobility component from people in residential care may result in local authorities or Scottish Government having to make alternative arrangements to ensure people are not trapped at home.
- The Citizens Advice Bureau report 200,000 benefits issues in 2010. ESA is now the biggest issue with more enquiries than credit card debt. However, CAB relies on volunteers to do this work.
