- Secretary submitted briefing paper Mass Relocations and Resettlement on the Tibetan Plateau as evidence to House of Common's Foreign Affairs Committee's inquiry on China and the international rules-based system. Discussion took place on CPGs use of the paper
- Presentation and discussion on childbirth in Tibet
- Presentation on fire which had broken out on 17th February at the Jokhang Temple, Lhasa.

9th May 2018 (Attendance: 4 MSPs, 18 non-MSPs):

- Mr Chonpel Tsering, Representative of His Holiness the Dalai Lama visited CPG and said a few words. Mr Tsering suggested that an event be held in Edinburgh to mark the 60th anniversary of the 14th Dalai Lama's exile to India
- Discussions took place around the visit of Sikyong Lobsang Sangay to the Scottish Parliament and what could be done to support Tibetan relations with China
- The secretary updated the group that the briefing paper *Mass Relocations* and *Resettlement on the Tibetan Plateau* was accepted by the Foreign Affairs Committee's inquiry on China
- A Tibetan news digest for the period March- May 2018 was circulated and its contents discussed
- The group received an update from Tashi Thondup on the progress of his Tibetan language and essay competition
- Suggestion that Tibet societies be re-established in Universities in Edinburgh and Aberdeen
- Discussion took place regarding a future talk on Tibetan writing
