Animals and Wildlife (Penalties, Protections and Powers) (Scotland) Bill

At the Stage Two debate of the Animals and Wildlife (Penalties, Protections and Powers) (Scotland) Bill on 26 May 2020, I said that I would write to the Committee with more information about the formation of a taskforce to consider the possible extension of powers to the Scottish Society for the Prevention of Cruelty to Animals (SSPCA) powers to allow them to investigate wildlife crimes.

As you know this topic has been discussed before the Committee on various occasions and the First Minister has stated in Parliament that the Scottish Government will consider the powers of the SSPCA.

I have also written to the SSPCA on this matter and they have replied to say that they welcome the approach that the Scottish Government is taking. I have included a copy of my letter and their response for your information in Annexes A and B of this letter.

Remit

While the remit of the taskforce is still to be finalised, I expect that they will examine, amongst other things, whether the current legislation is sufficient to enable the Scottish SPCA to carry out their existing functions in relation to the investigation of welfare offences against wild animals and whether the Scottish Government should give consideration to extending the powers of the SSPCA to enable them to carry out additional functions in relation to the investigation of wildlife crimes.

Membership

The membership of the group is still to be finalised, but I expect it to comprise of an independent chair, Scottish Government officials, and experts in law enforcement and

criminal justice, and will take evidence from interested groups including those involved with animal welfare, land management and conservation.

Timeline

I would expect the taskforce to convene later in the summer and that they will be in a position to conclude their review and submit a report of their recommendations before the end of the current Parliamentary session. However, for reasons I know the Committee will understand, these timelines may be subject to change due to the ongoing impact, and practical implications of responding to the COVID-19 pandemic and preparations for EU exit at the end of this year.

As I said when I spoke on this matter during the Stage 2 debate, I believe it would be inappropriate to pre-empt the findings of this taskforce by seeking to bring forward any legislative changes at this stage.

I hope this information is helpful, I will of course continue to keep the committee updated as we progress this work.

Animals and Wildlife (Penalties, Protections and Powers) (Scotland) Bill

At the Stage Two debate of the Animals and Wildlife (Penalties, Protections and Powers) (Scotland) Bill on 26 May 2020, I said that I would write to the Environment, Climate Change and Land Reform Committee with more information about the formation of a taskforce to consider the possible extension of powers to the Scottish SPCA to allow them to investigate wildlife crimes.

I would also like to provide you with an update on that work. While the full membership and remit of the taskforce is still to be finalised, I expect that they will be looking into, amongst other things, whether the current legislation is sufficient to enable the Scottish SPCA to carry out their existing functions in relation to the investigation of welfare offences against wild animals and whether the Scottish Government should give consideration to extending the powers of the SSPCA to enable them to carry out additional functions in relation to the investigation of wildlife crimes.

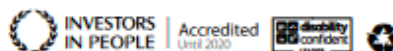
The taskforce will have an independent chair and will include representatives from the Scottish Government and experts in law enforcement. And of course I would expect that the Scottish SPCA will be an active participant in the work of the group.

In terms of timescales I hope that the taskforce will convene later this summer with a report and recommendations to follow in the New Year.

As I explained during the Stage 2 debate I do not wish to pre-empt the findings of this taskforce which is why I have not brought forth any amendments in this Bill that would alter the existing powers of the SSPCA. However, I can assure you that I will give my full consideration to the findings of the taskforce and any recommendations for legislative change that it may make.
